I have been lecturing on the History of Liberalism; John Dewey and the History of Pedagogy; Michel Foucault and French Anti-Humanism; Sigmund Freud and the History of Psychoanalysis; Haiti in Transnational and Global History; and the History of Dystopian Thinking and Fiction. I have also led seminars on texts written by, for example, Heraclitus, Saint Augustine, Hildegard of Bingen, Michel de Montaigne, Lucrezia Marinella, Mary Wollstonecraft, Immanuel Kant, J. S. Mill, and Friedrich Nietzsche.
